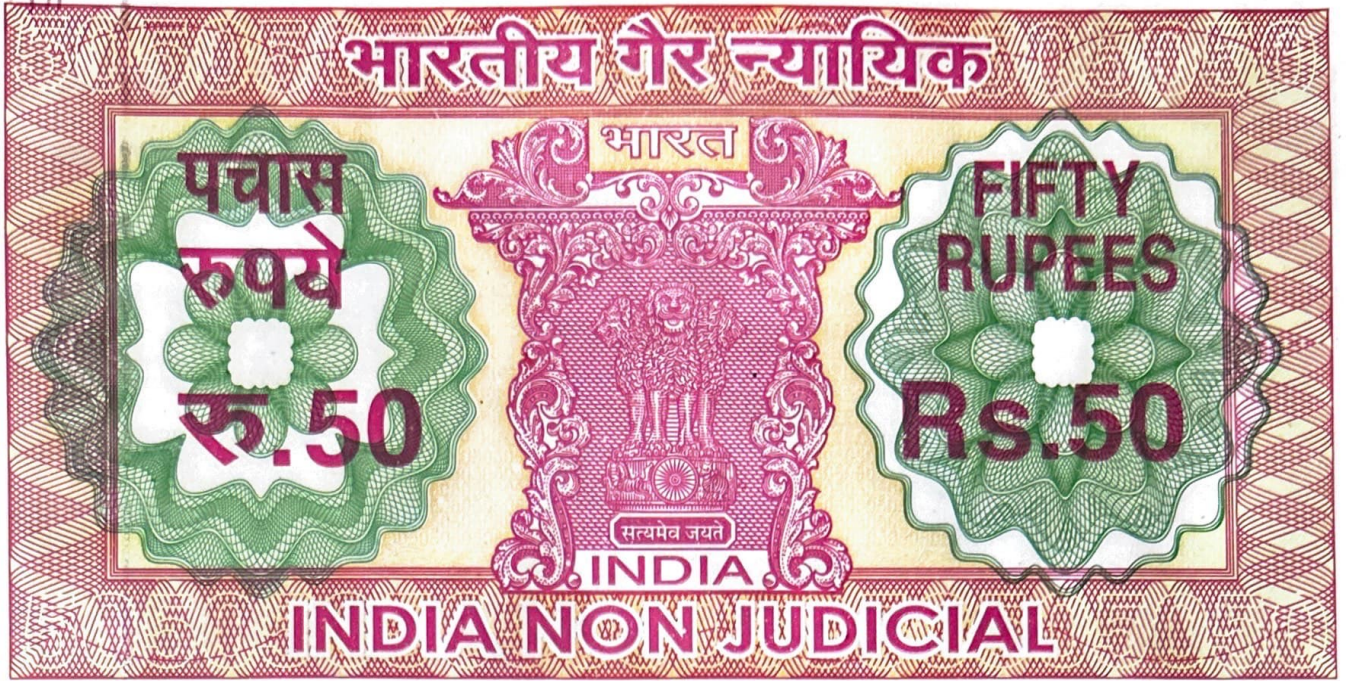

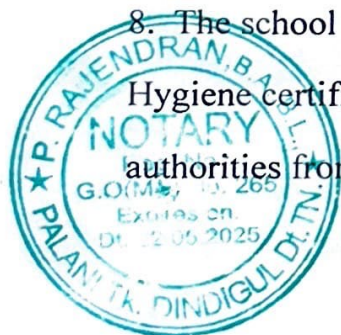

5. The school will not open classes under CBSE Pattern particularly classes IX / X / XI / XII and will not use CBSE name in any manner without obtaining due affiliation from the competent authority.
6. The principal and Correspondent /Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
